#### INTRODUCTION

The National Programme for Implementation of the SAA (NPISAA) 2022-2026 was approved by the Government of the Republic of Kosovo on 9 March 2022 and adopted by the Assembly of the Republic of Kosovo on 7 April 2022. It is a legally binding document for all state administration bodies which are obliged to implement short-term measures they are in charge of. The Government, as the central national mechanism responsible for the fulfilment of SAA obligations, oversees the implementation of the NPISAA through the institution legally mandated to coordinate the EU integration process - Office of the Prime Minister (OPM). The OPM, through the departments responsible for European integration, monitors the implementation of the NPISAA, on quarterly basis through regular reports. They serve to evaluate and improve the implementation of this Programme and for accountability and transparency within the institutions and to other stakeholders and the general public. Findings are discussed, inter alia, by the Government Cabinet and EU-Kosovo stabilisation and association bodies in charge of overseeing implementation of the SAA.

This is the second report for 2022 and covers the period from 1 July to 30 September. The data is reported by each responsible institution through the matrix of short-term measures and based on the guidelines for this purpose. In chapters where data were reported late or inadequately, they were not included in the report and the relevant measures were assessed as not fully implemented, i.e. they face major delays. The implementation of the Programme has been evaluated according to the progress status (presented in the Charts) and at two levels: for all measures and for the measures planned to be implemented during the reporting period (July-September). The implementation of all measures is assessed according to five levels of progress of implementation:

- Completed measures (those which are fully implemented) marked in blue;
- Measures being implemented, without delays (implementation has started and are expected to be fully implemented within the foreseen deadlines) marked in green;
- Measures with minor delays (implementation has started, but face minor delays and problems) marked in <a href="mailto:yellow">yellow</a>;
- Measures with major delays (envisaged to be implemented during the reporting period, but the
  implementation has not started yet, and face major delays) marked in rea; and
- Measures planned for the future (implementation has not started yet and were planned to be implemented in the remaining part of the year) marked in *grey*.

The implementation of the measures planned to be implemented within the reporting period is assessed according to two levels of progress of implementation:

- Implemented measures (those which are fully implemented) marked in *blue*; and
- Unimplemented measures (those which have not been implemented) marked in rea.

This Report contains four chapters and is divided into two sections: the section on the Programme as a whole and the section on each block. Chapter 0 provides an overview of the current situation, until the end of March, in the implementation of the Programme as a whole, in relation to the whole year and within the reporting period. This chapter is further divided into five parts: the part on the Programme as a whole, the part on political criteria, the part on economic criteria, the part on European standards, and the part by institutions. Each part contains the chart and the narrative part (explanation of the findings). The narrative part on each block is concluded with a qualitative assessment of the situation, which lists the measures that have not been implemented within the reporting period and those that are expected to face challenges during the following period.

Chapters 1, 2 and 3 are uniform - each containing two sections for each chapter of the Programme: the chart and the narrative part. The charts present the findings on the level of implementation of the relevant chapter: one *until the end of the reporting period* (compared to all the measures of the chapter) and the other *during the reporting period* (for the measures planned to be implemented within the period April – June). The narrative part gives a quantitative summary of these findings. The section on implementation until the end of the reporting period gives the number and percentage of measures implemented and those with other statuses of implementation out of all measures planned. The section on the level of implementation within the first quarter gives the number and percentage of measures implemented out of measures planned to be

implemented within this quarter. The narrative section also gives a brief qualitative assessment of the overall state of affairs in the relevant area. The Report also contains an annex that presents the state of implementation of all measures.

The findings indicate that *during the third quarter of* this year *the Programme* was implemented at the rate of 34.62%: 9 out of 26 measures planned for this quarter have been implemented, while 65.38% of them, 17 measures, have not yet been fully implemented (see chart 0.2, p. 6). Moreover, by the end of the third quarter, the entire Programme has been implemented at a rate of 29.37 %: 69 of 235 measures planned have been implemented, while 70.63% of them (166 measures) have not yet been fully implemented. Of these 69 measures, 18 of them were implemented before the deadlines (see the annex).

#### 0. OVERVIEW ON IMPLEMENTATION OF NPISAA DURING JULY-SEPTEMBER 2022

The programme contains 235 measures: 89 (37.87%) legislative measures and 146 (62.13%) implementing measures.

Chart 0.1. Implementation of NPISAA during July-September 2022: all measures



On implementation of the Programme by the end of the third quarter, findings indicate as follows:

- 29.37% of measures, 69 measures, have been implemented;
- 41.7% of measures, 98 measures, are being implemented, without delays;
- 3.4% of measures, 8 measures, face minor delays;
- 25.53% of measures, 60 measures, face major delays.

Of 69 fully implemented measures, 18 (26.08%) of them were implemented before the deadlines.

Of all programme measures, 26 (11.6%) of them were planned to be implemented during the third quarter: 10 legislative measures and 16 implementing measures.

Chart 0.2. Implementation of NPISAA during July-September 2022: measures planned for this quarter




On implementation of the Programme measures planned to be implemented during the third quarter, findings indicate as follows:

- 34.62% of measures, 9 measures, have been implemented;
- 65.38% of measures, 17 measures, have not yet been fully implemented, i.e., they face major delays.

Out of a total of 235 measures, the Programme contains 89 legislative measures, which constitute 37.87% of all measures.

Chart 0.3. Implementation of NPISAA during July-September 2022: all legislative measures




On implementation of legislative measures by the end of the third quarter, findings indicate as follows:

- 30.33% of measures, 27 measures, have been implemented;
- 40.44% of the measures, 36 measures, are being implemented without delays;
- 1.12% of measures, 1 measure, face minor delays;

• 28.08% of measures, 25 measures, face major delays.

Of all legislative measures, 10 measures (11.23%) were planned to be implemented during the third quarter.

Chart 0.4. Implementation of NPISAA during July-September 2022: legislative measures planned for the third quarter




On implementation of the legislative measures planned to be implemented during the third quarter, findings indicate as follows:

- 40% of the measures, 4 measures, have been implemented;
- 60% of the measures, 6 measures, have not yet been fully implemented, i.e., they face major delays.

Of 235 measures in total, the programme contains 146 implementing measures, which constitute 62.13% of all measures.

Chart 0.5. Implementation of NPISAA during July-September 2022: all implementing measures




On implementation of enforcement measures by the end of the third quarter, findings indicate as follows:

- 28.77% of measures, 42 measures, have been implemented;
- 43.16% of the measures, 63 measures, are being implemented without delays;
- 4.10% of measures, 6 measures, face minor delays;
- 23.97% of measures, 35 measures, face major delays.

Of all these implementing measures, 16 measures (10.95%) were planned to be implemented during the third quarter.

On implementation of the implementation measures planned to be implemented during the third quarter, findings indicate as follows:

- 31.25% of the measures, 5 measures, have been implemented;
- 68.75% of the measures, 11 measures, have not yet been fully implemented, i.e., they face major delays.

#### 0.1. State of Play by Blocks: Political Criteria

This block contains 17 measures: 4 (23.6%) legislative measures and 13 (76.4%) implementing measures

Chart 0.1.1. Implementation of NPISAA during July-September 2022: Political Criteria - all measures




On implementation of this block by the end of the third quarter, findings indicate as follows:

- 47% of measures, 8 measures, have been implemented;
- 29.5% of measures, 5 measures, under implementation, without delays;
- 23.5% of measures, 4 measures, face major delays.

Of all the measures of this block, 2 implementing measures (11.7%) were planned to be implemented during the third quarter.

On implementation of the measures of this block planned to be implemented during the third quarter, findings indicate as follows:

- 50% of measures, 1 measure, have been implemented
- 50% of the measures, 1 measure, have not yet been fully implemented, i.e., they face major delays.


Based on the findings of this report, the measures of this block planned for the reporting period which have not been implemented within the foreseen deadline are as follows:

- Approval by the Government of the draft-law on wages in the public sector;
- Approval by the Government of the draft-law on public officials;
- Approval by the Government of the draft-law on administrative inspection;
- Approval of the final report on the performance of executive agencies in the Government.

## 0.2. State of Play by Blocks: Economic Criteria

This block contains 3 implementing measures; all measures were planned to be implemented during the third quarter.

On implementation of this block during the third quarter and until the end of this quarter, findings indicate as follows:

- 33.33% of the measures, 1 measure, has been implemented;
- 66.67% of measures, 2 measures, face major delays.


Based on the findings of this report, the measures of this block planned for the reporting period which have not been implemented within the foreseen deadline are as follows:

- Approval of the concept document for supplementing and amending the Law on Public Enterprises;
- Approval of the Strategy for the Reform of Public Finance Management 2022-2026 and the Action Plan.

# 0.3. State of Play by Blocks: European Standards - Approximation of Kosova's Legislation with the EU Acquis

This block contains 215 measures: 85 (39.53%) legislative measures and 130 (60.46%) implementing measures.

Chart 0.3.1. Implementation of NPISAA during July-September 2022: European standards - all measures




On implementation of this block by the end of the third quarter, findings indicate as follows:

- 27.91% of measures, 60 measures, have been implemented;
- 43.25% of the measures, 93 measures, under implementation, without delays;
- 3.72% of measures, 8 measures, face minor delays;
- 25.12% of the measures, 54 measures, face delays with major delays.

Of all the measures of this block, 21 measures (8.57%) were planned to be implemented during the third quarter: 10 (47.61%) legislative measures and 11 (52.39%) implementing measures.

On implementation of measures of this block planned to be implemented during the third quarter, findings indicate as follows:

- 42.86% of measures, 9 measures, have been implemented;
- 57.14% of measures, 12 measures, have not yet been fully implemented, i.e., they face major delays.

Based on the findings of this report, the measures of this block planned for the reporting period which have not been implemented within the foreseen deadline are as follows:

- Development of the digital inspection platform;
- Approval of the concept document for the prevention of money laundering and the fight against the financing of terrorism;
- Adoption of the CA for investigation and discipline regarding the reporting of financial statements of companies, which transposes Directive 2006/43/ EC;
- Approving the AI on the licensing of operators of road transport of goods (completion change);
- Approval of the concept document for the prevention of money laundering and the fight against the financing of terrorism;
- Approval of the concept document for the transport of dangerous goods;
- Approval by the Government of the draft-law on the central criminal evidence system (new draft-law);
- Approval by the Government of the draft-law on religious freedoms in Kosova (amendment-change);
- Approval by the Government of the draft-law on the Independent Media Commission (amendment-change);
- Approval of the concept document for the realization of civil rights, including the right of the parties to trial within a reasonable time;
- Approval by the Government of the draft-law on school textbooks and teaching materials;
- UA approval for investigation and discipline;
- Drafting of the guide for the functioning of the Central Migration Authority;
- Finalization and launch of the Kosova Information System for Scientific Research (KRIS);
- Approval by the Government of the draft-law on school textbooks and teaching materials;
- Approval of the concept document for the inspectorate of the environment, water, nature, spatial planning, construction and housing;
- Drafting of the Sectoral Health Strategy 2022-2032.


The measures of this bloc that are expected to face challenges and delays and that require attention in the remainder of the year are as follows:

- Approval by the Government of the draft-law on public procurement (amendment-change);
- Approval of the regulation for cross-border delivery services;
- Approval by the Government of the draft-law on public procurement (amendment-change);
- Approval of the Strategy for Industrial Property;
- Acceptance of data for implementation, from the reports of Associations for Collective Management of copyrights to the Copyright Office (OCR);
- *Increasing the number of decisions of the State Aid Commission (KNSh);*
- Approval of the concept document for land regulation;
- Approval of the plan for protective measures for vulnerable consumers (electricity);
- Functionalization of the number portability system;
- Approval of the concept document for Review e policy tax;
- Completion of the project for the rehabilitation and modernization of the third phase of the 10th railway line (Mitrovica Leshak), including signaling and telecommunications;
- Approval by the Government of the draft labor law;
- Approval by the Government of the draft-law to supplement and amend Law no. 04/L-161 for Safety and Health at Work;
- Approval by the Government of the draft-law on the social assistance scheme;
- Approval of tourism strategy;
- Approval of the policy for industry development and business support;
- Appointment of two members of the Kosova Prosecutorial Council (KPC);
- Recruitment of seven mediation officers in the prosecutor's offices;
- Support of learning centers for Roma, Ashkali and Egyptian students;
- Establishing the liaison officer with EURPOL;

- National Science Programme Review;
- Revision of regulation 01/2018 for the operationalization of the National Contact Points for the 'Horizon' Program;
- Drafting and approval of the core curriculum for early childhood education;
- *Distribution of scholarships for pupils and students;*
- Approval of the strategic plan for the prevention and control of communicable diseases;
- Approval by the Government of the draft customs and excise code in Kosova (supplement-change);
- Moving to public property and fully operationalizing at least 2 customs terminals;
- Approval of the commercial policy document.

#### 0.4. State of Play by Institutions

This part gives an overview on state of implementation of the Programme according to the institutions that have planned to implement measures during the July-September period. In order to evaluate their performance, the institutions are ranked according to the percentage of measures implemented, from the one with the weakest performance to the one with the best performance.





As for the performance of Government institutions in the implementation of the measures under their responsibility planned to be implemented during July-September 2022, findings indicate as follows:

- Ministry of Education, Science, Technology and Innovation (MESTI) 0% (0/1 implemented measures);
- Ministry of Economy (ME) 0% (0/1 implemented measures);
- Ministry of Industry, Entrepreneurship and Trade (MIET) 0% (0/1 measures implemented);
- Ministry of Health 0% (0/1 implemented measures);
- Ministry of Finance, Labor and Transfers (MFLT) 0% (0/2 measures implemented);
- Ministry of Environment, Spatial Planning and Infrastructure (MESPI) 0% (0/3 measures implemented);
- Office of the Prime Minister (OPM) 40% (2/5 measures implemented);
- Ministry of Internal Affairs (MIA) 50% (1/2 measures implemented);
- Ministry of Justice (MoJ) 50% (2/4 measures implemented).




Chart 0.4.2. Implementation of NPISAA during July-September 2022: performance of other institutions

On the other hand, regarding the performance of other institutions in the implementation of the measures under their responsibility planned to be implemented during the July-September period, the findings indicate that the following:

- Agency for Information and Privacy (AIP) 100% (1/1 measures implemented);
- Civil Aviation Authority (CAA) 100% (1/1 measures implemented);
- Public Procurement Regulatory Commission 100% (1/1 implemented measures).


#### 1. BLOCK 1: POLITICAL CRITERIA

# 1.1. Democracy and Rule of Law

#### 1.1.1. Constitution, Parliament and Election System

This chapter contains 2 measures: 1 legislative measure (50%) and 1 implementing measure (50%); no measures were planned to be implemented during the third quarter.

Chart 1.1.1. Implementation of NPISAA during July-September 2022: Constitution, Parliament and Election System - all measures




Regarding the progress status of the implementation of this chapter until the end of the first quarter, the findings indicate that the 2 measures planned have been implemented.

As findings of the report indicate, all measures planned in this sector have been implemented. On July 28, 2022, with 81 votes in favor, none against and no abstentions, the Assembly approved the new Regulation of the Assembly of the Republic of Kosova. Also, on July 1, 2022, in the plenary session of the Assembly of the Republic of Kosova, the Ad-Hoc Commission for Electoral Reform was established. After that, the Advisory Group of this commission is established by the Commission itself. This commission consists of 11 members and is led by the largest opposition parliamentary group of this legislature.

#### 1.1.2. Public Administration

This chapter contains 13 measures: 3 (23%) legislative measures and 10 (76%) implementing measures.

Chart 1.1.2.1. Implementation of NPISAA during July-September 2022: Public Administration - all measures




On implementation of this chapter by the end of the third quarter, findings indicate as follows:

- 46.15% of measures, 6 measures, have been implemented;
- 23.08% of measures, 3 measures, are being implemented without delays;
- 30.77% of measures, 4 measures, face major delays. These measures are as follows:
  - o Draft-law on wages in the public sector, approved;
  - o Draft-law on public officials, approved;
  - o Draft-law on administrative inspection, approved;
  - The final report on the performance of executive agencies in the Government, approved.

Of all measures of this chapter, 2 implementing measures (16.6%) were planned to be implemented during the third quarter.

On implementation of the measures of this chapter planned to be implemented during the third quarter, findings indicate as follows:

- 50% of measures, 1 measure, have been implemented;
- 50% of measures, 1 measure, have not yet been fully implemented, i.e., they face major delays.

As findings show, this sector faces serious delays. Although the draft-laws on salaries in the public sector and on public officials have been finalized, they are still in the consultation phase and are expected to be submitted for Government approval during the third quarter. The draft-law on administrative inspection has been finalized by the working team, preliminary and public consultations have been carried out, it has not yet been proceeded for Government for approval. The final report on the performance of the executive agencies in the Government has been drawn up, but due to the assessment of the current situation by the executive agencies and the responsible ministries, it has not been approved by the Government, but it recommends that the responsible institutions start implementing the relevant regulation.

## 1.1.3. Ombudsperson

This chapter contains 2 implementing measures; no measures were planned to be implemented during the third quarter.

As for the progress status of the implementation of this chapter until the end of the first quarter, the findings indicate that 2 measures planned are being implemented without delays.

As findings indicate, this sector generally has no delays and measures planned are being implemented. On the number of Ombudsperson's recommendations implemented by authorities in charge, indicator 7.3.2 of the Sectoral Budget Contract for PAR has been reached. At least 60% of all recommendations addressed to central government institutions, issued in 2019 and 2021, to which central government institutions have responded positively, have been implemented. Based on the data provided by the OI, 116 recommendations out of 213 have been implemented, or the degree of implementation, according to indicator 7.3.2, is 75%. The number of responses received by authorities in charge during this period is as follows: For 8 recommendations institutions have provided answers within the legal deadline of 30 days; 1 institution did not respond at all regarding the recommendations; 2 recommendation for which no response is required from the Institutions within the legal term of 30 days; 2 recommendations which still has a deadline for reporting.



# 2.1. Existence of a Functional Market Economy

this chapter It contains 2 provision implementing; both measures were planned to be implemented during the third quarter.

As for the implementation of this chapter by the end of the third quarter, the findings indicate that the 2 measures have not yet been fully implemented, i.e., they face major delays. The measures are as follows:

- Draft document for supplementing and amending the law on Public Enterprises, approved;
- PFMR Strategy (2022-2026) and Action Plan, approved.

As findings of the report indicate, all measures planned for this quarter face delays serious IN implementation, one measure is the approval of the Concept document for supplementing and amending the Law on Public Enterprises, even though this quarter was the deadline for the implementation of this measure, there was no any development concerning with this concept document, where the other measure planned for this quarter, which is facing delays, is related to approval of the Strategy on Public Finance Management Reforms (2022-2026) and its Action Plan. The strategy is currently in the stage of inter-ministerial consultations and is expected to be approved by the end of October.

## 2.2. Capacity to Cope with Competitive Pressure and Market Forces within the Union

This chapter contains 1 implementing measure, planned to be implemented during the third quarter.

Chart 2.2.1. Implementation of NPISAA during July-September 2022: The capacity to face competition pressure and market forces within the Union - all measures.



With regards to the implementation of measures within this chapter by end of the third quarter, the findings indicate that the measure planned has been implemented.

As findings of the report indicate, the measure of this chapter planned to be implemented during this quarter has been implemented. This measure is the revision of the Programme for the reduction of the administrative burden, this programme which was approved by the government in September 2022.

# 3.0. Legal Framework on Approximation of Kosova's Legislation with the EU Acquis

This chapter contains no measures.

# 3.1. Acquis Chapter 1: Free Movement of Goods

This chapter contains 7 measures: 3 legislative measures (42.85%) and 4 implementing measures (57.14%).

On implementation of this chapter by the end of the third quarter, findings indicate as follows:

- 42.85% of measures, 3 measures, have been implemented;
- 42.85% of measures, 3 measures, are being implemented without delays;
- 14.28% of measures, 1 measure, face major delays. The measure is as follows:
  - Digital inspection platform, developed.

Of all measures of this chapter, 1 implementing measure (14.2%) was planned to be implemented during the third quarter.

As for the measure of this chapter planned to be implemented during the third quarter, the findings indicate that 1 measure planned has not yet been fully implemented, thus facing major delays.

As findings of the report indicate, there has generally been progress in this area. However, one measure faces major delays, specifically we are dealing with the development of the digital platform for inspections which is in the process of tendering for the selection of the company for the development of the digital platform.

On implementation of this chapter by the end of the third quarter, findings indicate as follows:


- 50% of measures, 2 measures, have been implemented;
- 25% of measures, 1 measure, is being implemented, without delays;
- 25% of measures, 1 measure, face major delays. This measure is as follows:
  - o Regulation on cross-border delivery services of remittances, approved.

As findings of the report indicate, this area generally has no delays and the measures planned are being implemented. However, one measure faces major delays and the reason lies in the fact that ARKEP has been instructed by CEFTA representatives regarding the regulation, and the given recommendations cannot be made at the moment. Only after its signature, ARKEP as well as all CEFTA member states will be given guidance on how to issue this regulation in accordance with the CEFTA agreement.

On implementation of this chapter by the end of the third quarter, findings indicate as follows:


- 50% of measures, 1 measure, have been implemented;
- 50% of measures, 1 measure, face major delays. This measure is as follows:
  - Draft document on Prevention of Money Laundering and Combating Financing of Terrorism, adopted.

As findings of the report indicate, this sector faces major delays in the implementation of one of the measures planned, namely the adoption of the Concept Document for the Prevention of Money Laundering and Combating the Financing of Terrorism. The expert engaged by the Council of Europe Project (PECK III) has completed the review of the draft Concept document. At the end of July 2022, the Financial Intelligence Unit forwarded the draft Concept document for comments and review to the cabinet of the Minister of Finance, Labor and Transfers.

# 3.5. Acquis Chapter 5: Public Procurement

Chart 3.5.2. Implementation of NPISAA during July-September 2022: Public Procurement - measures planned for this quarter




On implementation of the measures of this chapter planned to be implemented during the third quarter, the findings indicate that 1 measure planned has been fully implemented.

As findings of the report indicate, in this area 1 measure, the approval by the Government of the draft-law on public procurement, planned to be approved by the end of the second quarter, faces major delays. The Working Group has completed the drafting of this draft-law, but the final draft is being reviewed by the management of MFLT and has not yet managed to be sent to the Government for approval. As for the other measure, the Memorandum of Understanding between PPRC and the Competition Authority was signed on September 26, 2022.

Chart 3.6.1. Implementation of NPISAA during July-September 2022: Company Law - all measures




On implementation of this chapter by the end of the third quarter, findings indicate as follows:

- 66.67% of measures, 2 measures, are being implemented without delays;
- 33.33% of measures, 1 measure, face major delays. This measure is as follows:
  - o AI on investigation and discipline, approved.

Of all measures of this chapter, 1 measure (33.33%) was planned to be implemented during the third quarter.

Chart 3.6.2. Implementation of NPISAA during July-September 2022: Company Law - measures planned for this quarter




As for the measure of this chapter planned to be implemented during the third quarter, the findings indicate that the measure planned has not yet been fully implemented, thus facing major delays.

As findings of the report indicate, for the measure which is facing major delays, the working group established by the KCFR has completed the work of drafting the AI on investigation and discipline, having passed preliminary and public consultations, it has been sent to the cabinet for approval. Measures planned for the fourth quarter are being implemented. The concept document for commercial companies has been finalized, preliminary and public consultations have been completed and the consultation report has been submitted. Soon it is expected to be sent to the MIET cabinet and then to the Government for approval. Regarding the drafting of the BRIS compliance analysis, MIET is looking for a qualified expert. During the year, with the support of the project funded by LexDev for European integration, an expert will evaluate the KBRA database and hold training for its responsible staff.

# 3.7. Acquis Chapter 7: Intellectual Property Law

This chapter contains 4 implementing measures; no measures were planned to be implemented in the third quarter.

On implementation of this chapter by the end of the third quarter, findings indicate as follows:

• 50% of measures, 2 measures, are being implemented, without delays;

- 50% of measures, 2 measures, face major delays. These measures are as follows:
  - Strategy for Industrial Property, approved;
  - The data on the implementation, from the reports of the Associations for Collective Management of copyrights in the OCR, received.

As the report's findings show, the measure planned to be implemented during the third quarter – the adoption of the Strategy for Industrial Property – faces major delays in implementation. The working group has completed the final draft of the strategy, but it remains to be approved by the MIET cabinet and to be submitted to the Government for approval. As for the measure planned to be implemented in the fourth quarter, we estimate that even this measure will not be able to be implemented within the predetermined deadline. This measure is the acceptance of data for implementation from the reports of the Associations for Collective Management of copyrights in the OCR. After a large number of cable broadcasters objected to the government's decision to pay a flat fee for broadcasting copyrighted material, a lawsuit was filed to overturn the decision.

# 3.8. Acquis Chapter 8: Competition Policy

This chapter contains 5 measures: 2 (40%) legislative measures and 3 (60%) implementing measures; no measures were planned to be implemented in the third quarter.

On implementation of this chapter by the end of the third quarter, findings indicate as follows:

- 80% of measures, 4 measures, are being implemented without delays;
- 20% of measures, 1 measure, face major delays. This measure is as follows:
  - The number of SAC decisions, increased.

As the report's findings show, only one measure in this area is estimated to face major delays. Although all the measures are planned for the last quarter of the year, we can estimate that this measure will not be able to be implemented within the planned deadlines. The main reason for the delays related to this measure is the lack of appointment of the new State Aid Commission, since the mandate of the previous Commission expired in March of this year, therefore, in the absence of a quorum, the Commission cannot make decisions.

## 3.9. Acquis Chapter 9: Financial Services

This chapter contains 2 measures: 1 (50%) legislative measure and 1 (50%) implementing measure; no measures were planned to be implemented during the third quarter.

Chart 3.9.1. Implementation of NPISAA during July-September 2022: Financial Services - all measures




On implementation of this chapter by the end of the third quarter, the findings indicate that 2 measures planned are being implemented without delays.

As findings of the report indicate, there are no delays in the implementation of measures in this area, so they are being implemented according to plan. The regulation for liquidity risk management has been finalized and sent to the Board for approval, while regarding the other measure, CBK, through technical assistance from the World Bank, is finalizing the Roadmap for Solvency II, which will include the necessary actions and deadlines for preparation and the implementation of Solvency II.

# 3.10. Acquis Chapter 10: Information Society and Media

This chapter contains 15 measures: 12 (80%) legislative measures and 3 (20%) implementing measures; no measures were planned to be implemented during the third quarter.

On implementation of this chapter by the end of the third quarter, findings indicate as follows:


- 13.33% of measures, 2 measures, have been implemented;
- 60% of measures, 9 measures, are being implemented without delays;
- 6.67% of measures, 1 measure, face minor delays;
  - o The number portability system, created and operationalized;
- 20% of measures, 3 measures, face major delays. These measures are as follows:
  - o Digital Agenda for Kosova 2030, approved;
  - o Regulation on Portability of Numbers, approved;
  - Regulation for the protection of children and minors in audio and audiovisual media services, approved;
- 66.67% of measures, 10 measures are planned to be implemented during the last quarter.

As findings of the report indicate, over half of measures planned in this sector are being implemented. However, some measures face major delays, therefore special importance should be given to the adoption of secondary legislation, namely regulations from the field of electronic communications and audiovisual policies which are planned to be adopted/implemented during 2022, as well as the adoption of the Digital Agenda for Kosova 2030. Therefore, during the next quarter, the institutions must intensify their commitments and actions towards the implementation of all the first measures for the next quarter, as well as those measures that have not been fulfilled from the previous quarters.

#### 3.11. Acquis Chapter 11: Agriculture and Rural Development

This chapter contains 5 measures: 1 (20%) legislative measure and 4 (80%) implementing measures; no measures were planned to be implemented during the third quarter.

On implementation of this chapter by the end of the third quarter, findings indicate as follows:

- 40% of measures, 2 measures, have been implemented;
- 20% of measures, 1 measure, are being implemented without delays;
- 20% of measures, 1 measure, face minor delays, as follows:
  - o Concept document for land regulation.
- 20% of measures, 1 measure, face major delays, as follows:
  - o Programme for Agriculture and Rural Development 2022-2028;

As findings of the report indicate, some measures planned in this area have been implemented, or are being implemented. However, as presented above, the approval of the Agriculture and Rural Development Programme 2022-2028 faces major delays. The approval of this Programme is scheduled to take place during the first quarter, but it has not been completed yet, as the ex ante evaluation by the EU-funded project must be done beforehand. As soon as the ex-ante evaluation is completed, in parallel with the incorporation of the comments and recommendations of this evaluation (within the month of October 2022), in principle the document will be prepared to proceed further to the Government meeting for approval. In addition, the approval of the concept document for land regulation faces minor delays, where during the reporting period (third quarter), no meeting was held to draft this concept document.

#### 3.12. Acquis Chapter 12: Food Safety, Veterinary and Phytosanitary Policies

This chapter contains 6 measures: 2 (33.33%) legislative measures and 4 (66.67%) implementing measures; no measures were planned to be implemented during the third quarter.

On implementation of this chapter by the end of the third quarter, findings indicate as follows:

• 50% of measures, 3 measures, have been implemented;

- 16.67% of measures, 1 measure, are being implemented without delays;
- 33.33% of measures, 2 measures, face major delays. These measures are as follows:
  - o AI on the implementation of the AI on determining the health rules for animal by-products and their derivatives which are not intended for human consumption (new bylaw), approved;
  - o 14 Standard Operating Procedures (SOP) for monitoring quarantine organisms (high priority organisms), approved.

As findings of the report indicate, half of the measures planned in this area have been implemented. During the reporting period, the AI was approved on the definition of health rules for animal by-products and their derivatives, which are not intended for human consumption. After the approval of this Administrative Instruction, the transfer of references to the CA for the implementation of the preliminary CA has begun. On the 14 Standard Operating Procedures (SOPs) for monitoring quarantine organisms, there was ambiguity in their implementation procedures, and after consultations, it was understood that these PSOs have a legal basis in the Plant Protection Law no. 04/L-120 and the AUV is required to draft 14 guidelines for the implementation of these PSOs. These 14 guidelines will be drafted during the next quarter and will be approved by the Director of AUV.

#### 3.13. Acquis Chapter 13: Fisheries

This chapter contains no measures.

# 3.14. Acquis Chapter 14: Transport Policy

This chapter contains 19 measures: 15 (78.95%) legislative measures and 4 (21.05%) implementing measures.


Chart 3.14.1. Implementation of NPISAA during January - September 2022: Transport Policy - all measures

- 36.84% of measures, 7 legislative measures have been implemented;

- 31.58% of measures, 6 measures, face major delays. These measures are as follows:
  - o Draft-law on road transport, approved;
  - o Draft document for the transport of dangerous goods, approved;
  - o AI on technical control of vehicles, approved;
  - o AI on mobile technical control, approved;
  - AI on the licensing of road freight transport operators, approved;
  - Completion of the design project for the rehabilitation and modernization of the third phase of the 10th railway line.

On implementation of the measures of this chapter planned to be implemented during the third quarter, findings indicate as follows:


- 33.33% of measures, 1 measure, have been implemented;
- 66.67% of measures, 2 measures, have not yet been fully implemented, i.e., they face major delays.

As findings of the report indicate, some of the measures have been implemented, but also a significant part of the measures are being implemented. Also, some measures face major delays as well as the completion of the design project for the rehabilitation and modernization of the third phase of the 10th railway line. Consequently, the responsible institutions should pay special attention to the drafting of the road transport law, as well as to the above-mentioned Als. Therefore, during the following quarter, the responsible institutions must intensify their actions for the implementation of all the measures foreseen for the next quarter and those measures that have not been implemented from the previous quarters.

#### 3.15. Acquis Chapter 15: Energy

This chapter contains 8 measures: 3 (37.5%) legislative measures and 5 (62.5%) implementing measures.

- Approval of the Plan on protective measures for vulnerable consumers.


Of all measures of this chapter, no measure was planned to be implemented during the third quarter.

As findings of the report indicate, 2 measures have been implemented and most of the measures planned are being implemented. Until this reporting period, the Draft-law on mandatory oil reserves and AI on energy services (ESCO) for the private and household sectors has been approved. 4 measures (1 legislative and 3 implementing) are being implemented and 2 implementing measures (Energy Strategy 2022-2031 and Plan for protective measures for vulnerable consumers) face major delays. Therefore, during the next quarter, the responsible institutions must intensify the actions for the implementation of the measures planned for the next quarter and those measures that were not implemented in the previous quarters.

As findings of the report indicate, two of the three measures of this chapter are being implemented without delay. One measure faces major delays in implementation, namely the approval of the concept document on tax policy review. The draft drawn up by the working group has been sent to the Cabinet of the MFLT and its relationship with personal income tax policies, corporate income Taxation and value added Taxation is being evaluated.



As findings of the report indicate, two of the three measures planned are being implemented. Furthermore, data collection is related to the approval of the Law on Population Registration. The draft-law has not yet passed the second reading in the Assembly, therefore, without the completed law, the population census process cannot begin.

#### 3.19. Acquis Chapter 19: Social Policy and Employment

This chapter contains 7 measures: 3 (42.56%) legislative measures and 4 (57.44%) implementing measures; no measures were planned to be implemented during the third quarter.

On implementation of this chapter by the end of the third quarter, findings indicate as follows:

- 57.2% of measures, 4 measures, under implementation, without delays;
- 42.8% of measures, 3 measures, face major delays. These measures are as follows:
  - Labour law, approved;
  - o Draft-law amending the Law no. 04/L-161 on Safety and Health at Work, approved;
  - The draft-law on the social assistance scheme, approved.

As the report's findings show, there are major delays in implementation in this area. Specifically, there are major delays in the approval of the draft-law on safety and health at work, since taking into account the situation and the procedures until its approval, it is estimated that it will not be able to be approved within the deadline. The Labor Bill and the Occupational Health and Safety Bill also face major delays. Both bills have been finalized; have been submitted for internal consultation and to the Legal Department of the MFLT for further proceedings, respectively.

# 3.20. Acquis Chapter 20: Enterprise and Industrial Policy

This chapter contains 4 implementing measures; no measures were planned to be implemented during the third quarter.

On implementation of this chapter by the end of the third quarter, findings indicate as follows:

- 50% of measures, 2 measures, are being implemented, without delays;

  - o Tourism strategy, approved;
  - Policy for industry development and business support, approved.

As findings of the report indicate, half of measures planned have been implemented as planned, while the other half, 2 measures, face major delays: adoption of the tourism strategy and of the industry development and business support policy. The draft Strategy and AP on tourism has been finalized by the working group and proceeded for preliminary approval by the MIET Minister and then will be proceeded further. The analysis on performance of the industry in the economic, social and environmental dimensions, the analysis on sub-sectors and contributions to objectives set has also been finalized. Areas of intervention/sub-objectives and targets for the objectives have been set. Work is being done on the Action Plan, identifying challenges and proposing instruments to address these problems.



- 7.41% of measures, 4 measures, face minor delays. These measures are as follows:
  - o Recruitment of 7 mediation officers in basic prosecutor's offices;
  - o Concept document for displaced persons, approved;
  - o Scholarships for pupils and students, for the school year 2022/2023;
  - Support of Learning Centers for Roma, Ashkali and Egyptian students.
- 18.52% of measures, 10 measures, face major delays. These measures are as follows:
  - o Draft-law on the Central Criminal Evidence System (new draft-law), approved;
  - o Draft-law on administrative disputes, approved;
  - o Draft-law on religious freedoms in Kosova (amendment), approved;
  - o Draft-law on the Independent Media Commission (amendment), approved;

On implementation of the measures of this chapter planned to be implemented during the third quarter, findings indicate as follows:

- 42.86% of measures, 3 measures, have been implemented;
- 57.14% of measures, 4 measures, have not yet been fully implemented, i.e., they face major delays.

As findings of the report indicate, the measures planned in this sector have mostly been implemented or are being implemented. The delay is mainly in the draft-laws planned for this quarter: the draft-law on administrative disputes and the one on the central criminal evidence system. Drafting of the draft-law on religious freedoms and the one on the Independent Media Commission are in the final stage and are expected to be approved by the Government soon.

In terms of creating policies and advancing the institutional infrastructure in this sector, some key measures have not yet been implemented. In this regard, the concept document for the realization of civil rights, including the right of the parties to a trial within a reasonable time, has not yet been approved. The strategy for the protection and


promotion of the rights of communities is in the final stage of drafting, and regarding the concept document for displaced persons, the MKK, in consultation with GCS/OPM, is considering withdrawing this document, since the issues it would cover it is already covered by Law no. 03/L-047 on Protection and Promotion of the Rights of Communities and their Members in the Republic of Kosova.

In order to further advance the capacities in the prosecutorial and judicial system, the appointment of two members of the KPC and the recruitment of 7 mediation officers in the basic prosecutions remain challenging. Furthermore, although the Case Management System for displaced persons has been established and the training for the relevant officials has been completed, its full operationalization is expected.

Chart 3.24.1. Implementation of NPISAA during June-September 2022: Justice, Freedom and Security - all measures



As findings of the report indicate, the measures planned in this sector have mostly been implemented or are being implemented. There is a serious delay in the approval of the draft-law to supplement and amend the Law on Control and Supervision of the State Border, which was planned to be approved in the second quarter. The draft-law to supplement-amend the Law on Arms and the one to supplement-amend the Law on Foreigners (planned for the last quarter) are being finalized by the working groups, but face minor delays, which may turn into delays serious.

As for the advancement of the infrastructural capacities for border management, the API/PNR unit has not yet been operationalized, although steps have been taken in this direction, such as the appointment of the head of this unit by the Kosova Police, the connection of the KP servers with the IP/KKMK and holding trainings for officials who will work in this unit. Regarding the liaison officer with EUROPOL, the interviewing and testing have been completed and the appointment decision has been issued, however, until the full implementation of this measure, the systematization of the official remains, which is in the process of completion.

In the field of migration, the Guide for the operationalization of the AQM has not yet been approved. However, the MIA has revised the decision of 2013, according to the recommendations of the OPM, a decision which strengthens the role of the AQM and defines its duties and responsibilities in the function of migration governance. The CMA guideline is being drafted and is expected to be approved soon.

Chart 3.25. Implementation of NPISAA during July-September 2022: Science and Research - all measures





- Finalization and launch of the KRIS Platform;
- Revision of Regulation no. 01/2018 for the Functionalization of the National Contact Points for the 'Horizon' Program.

Of all measures of this chapter, 1 implementing measure (33.33%) was planned to be implemented during the third quarter.

Chart 3.25.2 Implementation of NPISAA during July-September 2022: Science and Research - measures planned for this quarter




On implementation of measures planned to be implemented during the third quarter, the findings indicate that 1 measure planned has not yet been fully implemented, thus facing major delays.

As findings of the report indicate, this area is characterized by major delays as the measures planned have not yet been implemented. The measure facing major delays is the Review of the National Science Program, which is expected to release an initial draft at the end of September. Also, the Review of Regulation 01/2018 for the functionalization of the National Contact Points, and the finalization and launch of the KRIS platform are facing major delays. It is recommended that you pay a lot of attention to the measures that have not yet been implemented at all.

Chart 3.26.1. Implementation of NPISAA during July-September 2022: Education and Culture - all measures




On implementation of this chapter by the end of the third quarter, findings indicate as follows:

- 25% of measures, 1 measure, has been implemented;;
- 25% of measures, 1 measure, is being implemented, without delays;
- 50% of measures, 2 measures, face major delays. These measures are as follows:
  - o The draft-law on textbooks and teaching materials, approved;
  - o Development and adoption of the core curriculum for early childhood education.

Of all measures of this chapter, 1 implementing measure (25%) was planned to be implemented during the third quarter.

Chart 3.26.2. Implementation of NPISAA during July-September 2022: Education and Culture - measures planned for this quarter




On implementation of measures planned to be implemented during the third quarter, the findings indicate that 1 measure planned has not yet been fully implemented, so it faces major delays.

As findings of the report indicate, most of the measures in this area are being implemented. The government has approved the draft-law on early childhood education 0-6, which aims to define norms for early childhood care, development and education, as well as the duties and responsibilities of early childhood education service providers. Special attention seems to be paid to the drafting of the core curriculum for early childhood education, since its non-implementation will lead to deficiencies in the implementation of the Law on Early Childhood Education.

# 3.27. Acquis Chapter 27: Environment

This chapter contains 9 measures: 3 (33.33%) legislative measures and 6 (66.67%) implementing measures.

On implementation of this chapter by the end of the third quarter, findings indicate as follows:

- 44.44% of measures, 4 measures, have been implemented;
- 33.33% of measures, 3 measures, under implementation, without delays;
- 22.22% of measures, 2 measures, face major delays. These measures are as follows:
  - o Draft-law on Kosova Waters (amendment), approved;
  - Concept document on the environment, water, nature, spatial planning, construction and housing inspectorate, approved.

Of all measures of this chapter, 1 measure (11.11%) was planned to be implemented during the third quarter: 1 (100%) implementing measure.

Chart 3.27.2. Implementation of NPISAA during July-September 2022: Environment - measures planned for this quarter




On implementation of the measures of this chapter planned to be implemented during the third quarter, the findings indicate that the measure planned has not been fully implemented, thus facing major delays.

As findings of the report indicate, most of the measures planned to be implemented in this sector have been implemented or are being implemented. Up to this reporting period, 4 measures have been implemented, while two measures are facing major delays (the Draft-law on Kosova Waters (amendment) and the approval of the Concept document on the inspectorate of the environment, water, nature, spatial planning, construction and housing. Therefore, during the following quarter, the responsible institutions must intensify their commitment and action towards the implementation of all the measures foreseen for the next quarter (Q4) as well as those measures that have not been fulfilled from the previous quarters.

#### 3.28. Acquis Chapter 28: Consumer and Health Protection

This chapter contains 7 measures: 5 (71.43%) legislative measures and 2 (28.57%) implementing measures.

On implementation of this chapter by the end of the third quarter, findings indicate as follows:

- 85.71% of measures, measure 6, are being implemented without delays;
- 14.29% of measures, 2 measures, face major delays. These measures are as follows:
  - o Sectoral Health Strategy 2022-2032, drafted;
  - o The strategic plan for the prevention and control of communicable diseases, approved.

Of all measures of this chapter, 1 implementing measure (14.29%) was planned to be implemented during the third quarter.

Chart 3.28.2. Implementation of NPISAA during July-September 2022: Consumer and Health Protection - measures planned for this quarter




On implementation of measures planned to be implemented during the third quarter, the findings indicate that 1 measure planned has not yet been fully implemented, so it faces major delays.

As findings of the report indicate, most of the measures in this field are not being implemented, so there are major delays regarding the adoption of legislation in the health field. Attention should be paid to the approval of the three draft-laws (for health insurance, for health, and for the prevention and control of communicable diseases) and the drafting of the AI on the implementation of the exemption from the payment of premiums, co-payments and co-financing for health services.

## 3.29. Acquis Chapter 29: Customs Union

This chapter contains 3 measures: 1 (33.33%) legislative measure and 2 (66.67%) implementing measures; no measures were planned to be implemented during the third quarter.

On implementation of this chapter by the end of the third quarter, findings indicate as follows:

- 33.33% of measures, 1 measure, is being implemented without delays;
- 66.67% of measures, 2 measures, face major delays. These measures are as follows:
  - o Approval of the draft customs and excise code in Kosova (amendment);
  - o Relocation to public property and full operationalization of at least 2 customs terminals.

As findings of the report indicate, in this area there are major delays in the adoption of the draft customs code, therefore special importance should be given to its proceeding by addressing internal comments and starting with public consultation and other required procedures. Actions have been taken regarding this measure - the working group has completed the final draft and sent it to the MFLT cabinet for review - but it is facing delays. The term of this draft code has also been changed in the Legislative Programme of the Government. Regarding the other measure that is facing major delays, 1 terminal is functional (in the facilities of Trepça), while public property has been designated for the other (in Vërmica) where 1 terminal will be built/functionalized, but the permit is still expected to be issued construction for the new facility.

# 3.30. Acquis Chapter 30: External Relations

This chapter contains 1 implementing measure; no measures were planned to be implemented during the third quarter.


• Trade policy document, approved.

Within the framework of the National Strategy, the Trade Policy Programme will be drawn up, which will be included in the Industrial Policy Strategy. Relevant institutions have been identified and the working group is expected to be created soon.

The draft-law on the implementation of targeted financial sanctions was approved by the Government in May 2022. On the other hand, we have two implementing measures, the Strategy for Foreign Policy and the Action Plan for political dialogue, which are currently being implemented.
