X Kana sile o detalya kay o personi sito astardo ano kriminalune aktivitetya vay mothavipe kay sile pe resipe vay ayekha diso.

## ➤ Sar gengyola periodi 90 dive andar periodi kotar 180 dive?

Periodi 90 dive shrdela sar kotar o momenti kana khuvena angluni ver ani zona Shengen. Misal, te sine kay pe data 1 yanuari 2024 khuvena angluni bver ani zona Shengen, avutno periodi shov masekuno shrdela palo 180 dive vay qaqipeya pe 29 yuni 2023. Ayekha kay andar akala 180 dive tumen shay te beshen ani zona Shengen numay 90 dive. Te sine kay drominenet buti ver ani zona Shengen, tumen musay te genen o aqhilie dive kotar paluno periodi shov masekuno.

- ✓ Mothavipe vash beshipe thay rezervipe e hotelesko vay yaver detalya e thaneske kote ka beshen;
- ✓ Detalya e dromipeske, leindoy kotor rezervipe e iranipeska biletako;
- ✓ Te sine kay dromingyola e vrda, mangle dokumentya e vrdake;
- ✓ Mothavipe kay situmen dosta financierune vastushya.

## ➤ Shay te drominav vash sastipesko sebepi?

Kana mothavgyola o sebepi tumenge dengyola shaipe e dromipesko ani zona Shengen vash sastipesko tretmani. Akava dromipe musay te ovel andar maksimaluno periodi kotar 90 dive.
